Financial Assistance:

SMF is applying to IE Singapore for Singapore Pavilion in **Beauty Connect Cambodia 2018** to be covered under the **International Marketing Activities Programme (iMAP)**.

If approved, the funding allows eligible companies to receive **up to 50%** subsidy of total eligible costs in space rental and stand construction.

Note: Companies may apply for Double Tax Deduction (DTD) for qualifying expenses not covered by iMAP. With effect from 01 Apr 12, the DTD has been enhanced to allow companies to automatically claim 200% tax deduction without prior approval from IE Singapore or STB. (up to the first S\$100,000 of qualifying expenses per year of assessment).

Qualifying Criteria

Eligible companies are defined as being incorporated and based in Singapore (exclude branch of a foreign company) & locally registered with **at least 3** of the following core business functions

- **Market development and planning**
- **Logistics and shipping management**
- **Business and investment planning**
- **Research & development and design functions**
- **Banking, financial & treasury functions**
- **Manufacturing & other value-added activity**

***If iMAP Funding is Approved :** The above amount is before reimbursement of iMAP's approved amount. Reimbursement to exhibitors will be made after SMF receives the said amount from IE Singapore.

- ◆ SMF members are required to pay an administration fee of **\$220** of which amount is not eligible for claim under the iMAP scheme.
- ◆ GS1 members are required to pay an administration fee of **\$280** of which amount is not eligible for claim under the iMAP scheme.
- ◆ Non-SMF members are required to pay an administration fee of **\$500** of which amount is not eligible for claim under the iMAP scheme.

Please note that IE Singapore reserves the right to verify information provided by the companies. Eligibility and subsidy reimbursement of individual companies are subjected to final claim approval.

- a) iMAP is not a direct subsidy for expenses incurred by participating companies.
- b) iMAP is intended to offset the bona fide eligible costs paid by TAC to 3rd party suppliers in organizing the activity.
- c) TAC shall not misappropriate the participating fees collected from participating companies.
- d) TAC is responsible for all expenses related to the activity and will seek reimbursement for eligible expenses from IE Singapore on behalf of participating companies.
- e) IE Singapore will not be responsible to the participating companies in the event that TAC defaults in making payment to the participating companies
